WHAT MAKES THIS GIFT UNLIKE OTHER FORMS OF CHURCH GIVING?

Our Legacy Fund is a permanent fund and only its annual earnings are utilized, unless otherwise specified by the grantor. When income is available and distributed, it supports projects above and beyond normal budgeted items.
